### What NOT To Do!

- Seize an asset without confirming ownership (i.e. Seize a leased car)
- Seize an asset without confirming you have enough costs advanced to cover storage, etc.
- Seize an asset without checking PACER for bankruptcy
- Hire Disreputable Constables to Assist in Judgment Enforcement

### Special Real Estate Attachment

- Obtain a Special Real Estate Attachment against real property in which judgment debtor has an interest but which is held in the name of a third party
  - Trusts
  - "Side Agreement" with Owner

# Types of Valuable Personal Property

- Artwork
- Antiques
- Classic motor vehicles
- Jewels
- Collectibles

### Issues to Consider

- The Sheriff may not be the one to take possession and sell valuable personal property
- Possession issues and storage along with insurance can be an issue
- . The sheriff or public official is not set up to take such works into their possession

### Ownership Issues

- How do you determine who owns the artwork or valuable antique or collectible?
- Common word used in the industry is "Provenance"

### Ownership Issues

- Bill of sale (easily forged)
- UCC liens can attach to art and antiques
- Storage location may be able to provide ownership information
- Certificate of authenticity can be as valuable to the items as the item itself

### Is it a Forgery?


#### **FORGERY**

- Offered at an online auction
- Photocopies of the authenticity documents
- Unreadable signatures on bills of sale
- Unverifiable chain of ownership
- Names of all auction houses or galleries that have owned the art.

#### **AUTHENTIC**

- Offered at an exhibition or gallery
- Signed receipt from the artist
- Appraisal from a recognized authority or expert stating that the artwork is by the artist
- Newspapers or books recognizing the art.

### Attaching the Art or Antique



### What Motion to File?

- Check your local statues.
- Notice to anyone who may claim ownership?
- File Ex-Parte?
- Enjoin the Sale
- Garnish the storage facility or dealer with the item is being stored.

### **Preliminary Order**

- The court will bring all potential claimants before the court for a determination of ownership if in question.
- If ownership is clear through a clear uncontested bill of sale this step can be skipped

### Subsequent Orders

- The order should specify exactly who will pick up the item, where it will be stored and how it will be sold.
- Once ownership is established or if it already known for sure, the court can order a levy with special instructions.

### Issues with Sale

- Liability and insurance
- Possession, sale or appraisal
- Expenses of storage and insurance
- Voluntary or involuntary turnover with the help of the Sheriff
- Method, location and type of sale, public or private

### Post Sale Issues

- Who retains funds
- How are funds disbursed
- Lien and claimant priority determinations
- This may require an additional hearing depending on the claimants.







### Seizing Interest in Corp or LLC

- Seize Corporate Stock owned by individual judgment debtor
- Obtain a charging order against judgment debtor's interest in a Limited Liability Company
