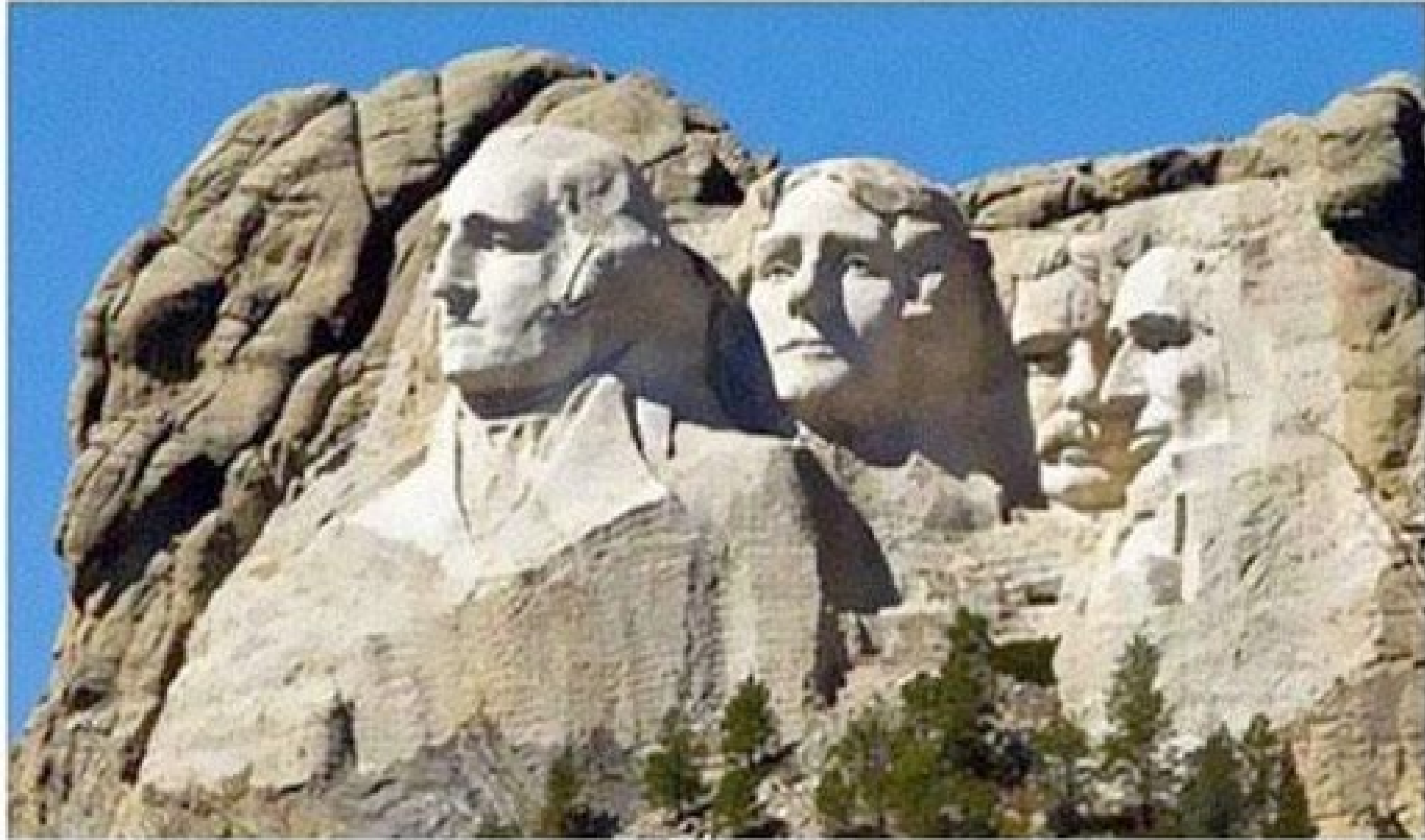

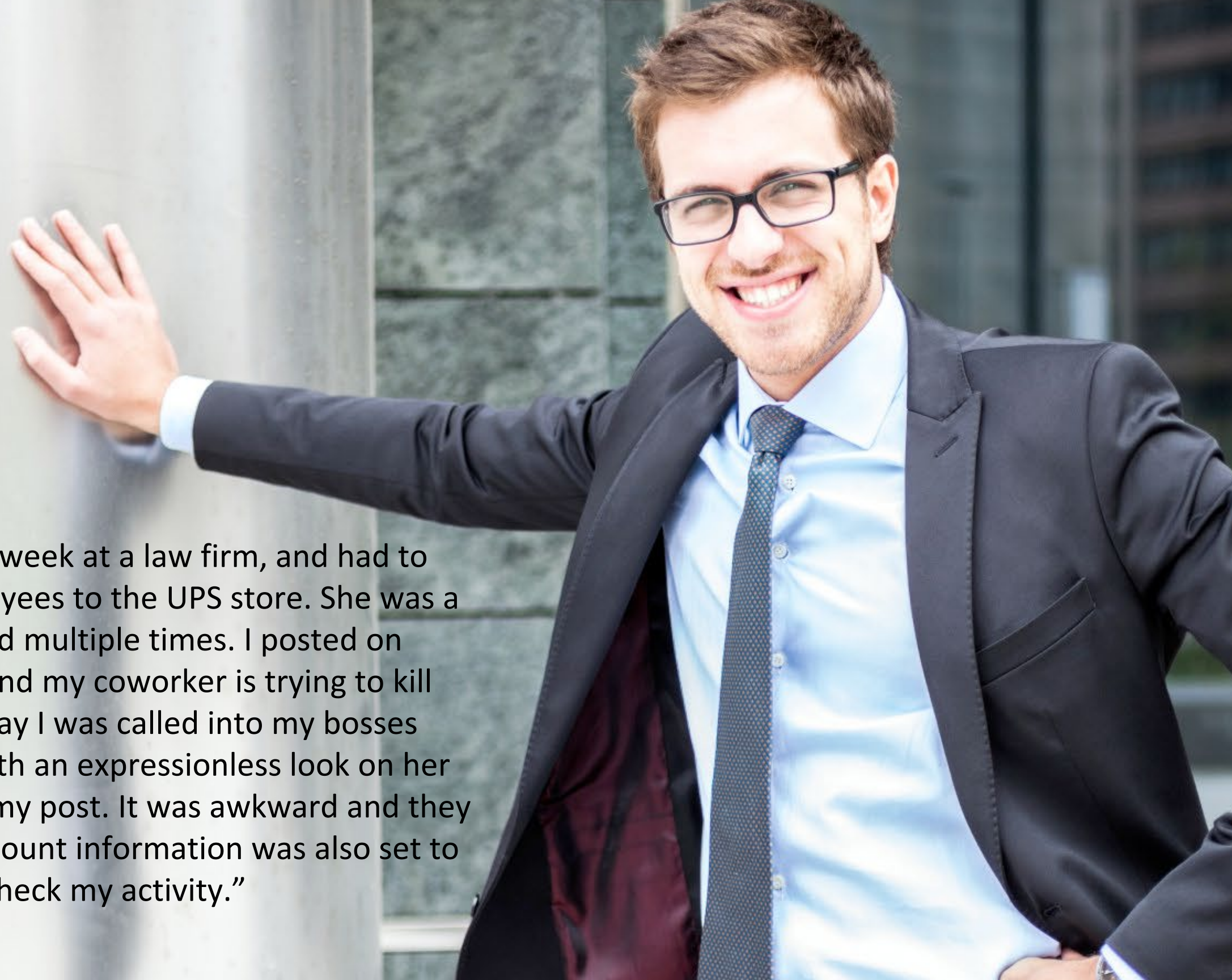

- **No fraud, deceit, dishonest or misrepresentations**
- **Must remove social media content posted by others that is fraudulent, deceitful or dishonest.**
- **Duty to monitor and remove social media content by others on lawyer's page**
- **Cannot use term specialist**
- **Must ensure accuracy of third-party legal endorsements**
